SYNOPSIS
Captain Bunger met with the victim at 10th and Fee Lane and took a report of theft of a sign.

NARRATIVE
On 10/4/18, around 1115 hours, John Summerlot advised that someone attempted to take one of the anti-abortion signs from 10th and Fee Lane. Sgt Allen and I responded to the area and met with Samuel Riley who was with the anti-abortion group. Mr. Riley stated the sign was on the SE corner of 10th and Fee Lane in the grass between the road and the sidewalk.

Riley stated that a black Hyundai Elantra pulled up, stopped, and the driver got out and ran around to the sidewalk. The driver then opened the passenger door, put the sign in the passenger seat, and closed the door. As the driver went back around to the driver's side, Mr. Riley opened the door and retrieved the sign. At this time, the driver got in the car and drove off. At this time, I can't confirm if the suspect is a student or not.

John Summerlot was able to take a picture of the license plate and the vehicle returned to a 2010 Hyundai Elantra, returning to Bonnie and Thomas Metcalf, Carmel, IN. Riley was wearing a Go-Pro camera and the camera captured the incident. Riley stated that he could email me the footage of the incident. Riley stated that this was really the only issue that they have had.
