SYNOPSIS  
Officer Koloms took a report in reference to vandalism.

NARRATIVE

On 10/04/2018 at 1338 hours Captain Bunger requested officers at the intersection of 10th St and Fee Ln due to a subject who was destroying demonstration signs.

Captain Bunger advised the male was wearing green pants and headed west on 10th St from Fee Ln. The individual was on a bicycle. I was sitting at the intersection of Forrest Ave and 10th St when I noticed a male matching the description of the suspect going west on 10th St. I activated my emergency lights and initiated a traffic stop at 10th St and Woodlawn Ave. Officer N. Lewis arrived to assist.

The male was identified as Thomas Metcalf who is a student of Indiana University. I had Metcalf sit on the curb and I asked him what was going on today. Metcalf continually asked if he was under arrest and stated that he would not talk to me without a lawyer. Metcalf then attempted to call his mom from his phone. After I continually told him to hang up the phone Metcalf ignored my commands until he was able to yell into the phone that he needed a lawyer and hung up.

I then read Metcalf the Miranda Warning to which he stated he understood. Officer N. Lewis again asked him what was going on today to which Metcalf immediately responded that he wanted a lawyer.

Officer Dreadfulwater spoke to Beth McIntosh who was a witness. Mcintosh stated that Metcalf had spray painted the front and back of multiple signs along with taking others apart and throwing them into

the grass of a nearby building. McIntosh filled out a sworn statement and I have attached it to this case. Officer Dreadfulwater took pictures of the damage done by Metcalf. The SD card was properly sealed and placed into evidence locker #7.

Most of the people working the demonstration were wearing GoPro cameras and stated they would send IUPD the video footage from the incident.

Officer N. Lewis spoke to Samuel Riley who also witnessed the incident and filled out a sworn statement. See his supplement for further information.

Due to the fact no officers witnessed the incident, Metcalf was released and advised of Disorderly Conduct. I did fill out a PC affidavit for Criminal Mischief and Disorderly Conduct and it has been attached to this case.
